Introduction

The National Strategic Framework - the Roma Equality, Inclusion and Participation Strategy by 2030 (hereinafter referred to as "2030 Strategy") - was adopted by the Government of the Slovak Republic on 07/04/2021 by Resolution No. 181/2021 on the Strategy for Equality, Inclusion and Participation of Roma by 2030. This framework strategic document is a commitment of the Government of the Slovak Republic, defining at the level of priorities the direction of public policies in order to achieve visible change in the field of equality and inclusion of Roma. The document contains four priority areas - employment, education, health and housing - which remain key to achieving the objectives. Particular emphasis is placed on non-discrimination and on stepping up interventions to combat anti-Roma racism.

The 2030 Strategy was developed on the basis of a request for a conceptual material that takes into account the development of the situation and the experience of the previous eight years since the adoption of the Strategy of the Slovak Republic for the Integration of Roma up to 2020 and the relevant action plans. It was also initiated by the joint efforts of the Member States of the European Union. Given its cross-ministerial nature, the 2030 Strategy is an umbrella document for the development and implementation of the planned strategic documents of the responsible ministries in the relevant areas, and also provides a link with existing materials.

The content of the 2030 Strategy contributes to the fulfilment of the Government's intentions in relation to the improvement of the status and situation of the Roma, as set out in the [Programme Declaration of the Government of the Slovak Republic for the period 2020-2024](#), section *Improvement of the status and situation of the Roma*, and also reflects the objectives of the Vision and Strategy for the Development of Slovakia until 2030. The National Strategy presents a set of starting points and objectives that aim to stop the segregation of Roma communities, to make a significant positive turn in the social inclusion of Roma, to ensure non-discrimination, to change attitudes and to improve coexistence. A prerequisite for the effectiveness of the National Strategy is implementation, which requires a cross-ministerial approach, active participation and cooperation between the levels of government, coordinated by a single entity. The coordinating role/agency in relation to the 2030 Strategy is fulfilled by the Plenipotentiary of the Government of the Slovak Republic for Roma Communities (hereinafter referred to as "PGSRRC") through the Office of the Plenipotentiary of the Government of the Slovak Republic for Roma Communities, which is also the National Focal Point.

The Strategy as an umbrella document is followed by Action Plans, which are developed in three-year cycles. The first Action Plans are created for the period 2022-2024, followed by the period 2025-2027 and 2028-2030. Action Plans are developed for each of the priority areas of the 2030 Strategy - education, housing, employment, health, and combating anti-Roma racism and promoting participation. The Action Plans contain elaborated global objectives and sub-objectives to the level of measures and activities, which have defined measurable indicators, responsible authorities and partners and a realistic quantification of the necessary financial requirements and identified appropriate resources to cover them.

Establishment of Action Plans for the period 2022-2024

The preparation of the Action Plans of the 2030 Strategy for the period 2022-2024 started in May 2021. A Thematic Working Group (hereinafter referred to as "TWG") was established for each priority area. Representation in the TWG was provided by the various ministries, according to their respective content competences, as well as by other state institutions and, last but not least, by non-governmental and non-profit organisations that have long been involved in the inclusion of marginalized communities, academia, and also by representatives of local and regional government. The TWG meetings took place between May 2021 and September 2021. Due to the unfavourable pandemic situation, most of the meetings were held in the online space. On the other hand, the online format of the TWG meetings facilitated participation and allowed for a broader representation of participants operating at the regional level.

In the framework of the working groups, the basic frameworks of the individual action plans were formulated and gradually complemented with concrete proposals for actions and activities. Internal and external experts for each area subsequently discussed with representatives of involved ministries and institutions within whose remit the proposed activities should be implemented, and the method of financing was also addressed. As a rule, these were bilateral negotiations at expert level, i.e. mainly at the level of sections and departments of the relevant ministries, or those entities that have assumed responsibility or partnership for the future implementation of the proposed activities. In the event of disagreement at the expert level, the disputed issues were discussed between the Plenipotentiary of the Government of the Slovak Republic for Roma Communities (personal change as of 09/12/2021) and the State Secretary/Secretary of the relevant ministry.

Working versions of the Action Plans were also sent to the TWG members on an ongoing basis. Additional suggestions and comments from TWG members were discussed with the responsible entities and the PGSRRC sought support and funding opportunities for these suggestions. The proposal of the specific amount of the financial allocation allocated for individual activities was based primarily on the proposals of the new programming period, i.e. the Programme Slovakia, on the currently implemented programmes and also on the possibilities of the state budget.

The draft Action Plans were also published for public comment and were subsequently discussed by the Steering Working Group, which is part of the Advisory Commission of the PGSRRC for the preparation of the revision and update of the 2030 Strategy, the development of its Action Plans and for implementation, evaluation, monitoring and assessment. A meeting of the Steering Working Group, which is mainly composed of State Secretaries and Secretaries of the concerned ministries, was held on 08/12/2021. The consultation process continued with technical negotiations with representatives of the European Commission. Once all the proposals and recommendations submitted had been processed, the draft Action Plans were submitted to the internal comment procedure, the preliminary comment procedure and then to the inter-ministerial comment procedure.
